In his last year at the firm, the Altamira Precious and Strategic Metals fund won the Precious Metals Equity Fund of the Year award at the Canadian Investment Awards (Morningstar).

From 2005 until 2017 Mr. Porter was employed as a Senior Portfolio Manager by Front Street Capital and once again had a primary focus on the natural resource sector. At the peak Mr. Porter managed close to one billion dollars in mandates, including being sub-advisor to CIBC for its natural resource funds (for eight years managed CIBC Resource, CIBC Energy, CIBC Precious Metals and Renaissance Global Resource funds.) He also was the fund manager for Front Street's flow-through product offerings, being directly involved in the marketing and raising of over \$900 million in capital for the limited partnerships.

Over the years Mr. Porter has been a frequent guest on news stations such as BNN, to express his thoughts, opinions, and recommendations, on natural resource stocks and global commodities markets. He's also been quoted in newspapers such as the Globe and Mail, National Post, and Toronto Star.
